2025 President's Report

2024-2025 Overview

Grace and peace in the name of our Lord Jesus Christ.

This past year has been one of steady effort, ongoing discernment, and hopeful progress for the Hawai'i District Union. As we move beyond the season of disaffiliation discernment, our focus is returning to the heart of our calling—ministry and the life-giving work Christ is doing in and through our churches and communities. This past year we created a formal partnership with Camp Mokulē'ia. Several of our churches have already participated in youth retreats and summer camps through this partnership. Additionally, Camp Mokulē'ia has generously extended an offer to provide a free two-night midweek stay for clergy, a gift of rest and renewal that several of our clergy have gratefully received. We are hopeful that this collaboration will continue to grow and bear fruit in the years ahead. This year, HUMU extended a conditional grant to the Wesley Foundation at the University of Hawai'i after they discovered critical structural issues in their building. This support allowed them to reroof the facility and address structural concerns, ensuring that this vital ministry to college students can continue safely and sustainably.

I am especially grateful to our District Superintendent the Rev. Tom Choi for his faithful leadership in identifying needs, fostering partnerships for ministry, and helping to carry out the mission of our church in both broad and practical ways.

HUMU Operating Budget

I am pleased to report that the HUMU operating budget continues to sustain and support the ministry of the Hawai'i District. In 2024, our total revenue was approximately \$1,981,871, a slight decrease from the previous year's \$2,049,525. However, our total expenditures also decreased, coming in at \$1,972,284, down from \$2,112,711 in 2023. This resulted in a net operating income of \$9,587.

In addition to operating income, our investments performed well, yielding \$154,652 in realized gains and \$132,671 in unrealized gains, alongside other forms of revenue, such as property rentals. After accounting for additional expenditures, including necessary property repairs and program-specific expenses, our net revenue for 2024 totaled \$213,667.

In November HUMU Board passed a balanced budget for 2025. Projected total revenues are approximately \$2,291,080, with projected expenditures closely matching at \$2,290,776. This

balanced approach reflects our continued commitment to faithful stewardship, adaptability, and strategic investment in ministry opportunities throughout the district.

I remain deeply grateful for the wise leadership of the HUMU Board and to Rosie Jacinto, our dedicated HUMU accountant, whose diligence and attention to detail make this ongoing stewardship possible.

Camp Mekokiko

Last year after many years of discernment, prayer and conversations, our district voted to sell Camp Mekokiko. We had the property professionally appraised. After consultation with our realtors and reviewing comparable listings, we chose to list the property at **\$2.3 million**. Since listing it in January the listing continues to generate interest online. In just a few months our realtors have done numerous showings from prospective buyers with various interests and visions for the space. Since Camp Mekokiko is 36 acres there are no comparables on the market offering that scope of land at that value. Our realtors believe that it may take longer than usual to find the right buyer—but remain confident that it is appropriately priced and will draw the right interest.

We are especially grateful to Louie Haddad, the property's caretaker, for his proactive efforts in preparing the site for listing and for his continued vigilance in maintaining the peace and protection of the land during this transitional period.

West Kaua‘i UMC

The district was also able to make important property upgrades at West Kaua‘i United Methodist Church, thanks to the newly negotiated lease signed with Child Family Services (Headstart preschool) in 2023. These improvements included significant electrical upgrades and mold remediation in the sanctuary at the Kekaha location. This thankfully addressed a safety concern as the preschool is in close vicinity to the church. Unfortunately due to the roof and mold issues, West Kauai UMC is worshipping solely at their Kaumakani location. We will be looking to renegotiate the preschool lease again at the end of 2025.

Pāhala Preschool

Due to the rising costs of property insurance, we were required to adjust the rent for Pāhala Preschool. While this was not an easy decision, it was necessary to ensure the continued maintenance and protection of the property.

RESOLUTION TO: The 2025 California-Pacific Annual Conference Of The United Methodist Church

SUBJECT: No Renewal Of Military Leases On O‘ahu

SUBMITTED BY: Hawai‘i District United Methodist Church Acts of Repentance Task Force

ESTIMATED FINANCIAL IMPACT: None

SOURCE OF STAFF TIME: None

WHEREAS, on January 17, 1893 American businessmen and leaders orchestrated the illegal overthrow of the Hawaiian Kingdom and Queen Lili‘uokalani. In spite of five treaties signed by the U.S. Government with the Hawaiian Kingdom, and the fact that sixteen other nations maintained official diplomatic ties with Honolulu, resident businessmen – some of whom were descended from the original missionaries – calling themselves “the Committee of Safety” seized power by illegally occupying the government building, with the assistance of 162 U.S. Marines and Navy sailors;

WHEREAS, according to newspaper articles and church archival documents, the Rev. Dr. Harcourt W. Peck supported the illegal overthrow and served as sharpshooter and acting adjutant for Colonel J. H. Fisher, commander of the forces who dethroned Queen Lili‘uokalani. When he returned to Hawai‘i a year later to serve as pastor of First Methodist Episcopal Church, he rejoined the sharpshooter company and served as chaplain of the new forcibly established Republic of Hawai‘i. Rev. Peck's armed participation against the legal and internationally recognized indigenous government of Hawai‘i, as well as his continued solidarity with those who orchestrated the overthrow, solidified First Methodist Episcopal Church's establishment in Honolulu and ensured the continuation of Methodism in Hawai‘i;

WHEREAS, the 2020/2024 United Methodist Church General Conference passed a resolution to acknowledge the history of racism and imposed colonial rule in Hawai‘i from the illegal overthrow to the present, and initiated an apology on behalf of the United Methodist Church for the church’s role and complicity in the overthrow;¹

WHEREAS, the Hawai‘i District Acts of Repentance Task Force was established to nurture authentic community with Native Hawaiians and make the church’s apology meaningful;²

WHEREAS, in 1964 the U.S. Army signed 65-year leases for \$1 per lease with the State of Hawai‘i, Department of Land and Natural Resources, for 782 acres at Makua Military Reservation (MMR), 1,150 acres of land at Kahuku Training Area (KTA), and 4,390 acres at Kawaihoa-Poamoho Training Area (Poamoho);

WHEREAS, the US Army leases of lands of “State of Hawai‘i” lands at MMR, KTA, and Poamoho totaling 6,322 acres on the island of O‘ahu are set to expire in 2029;

WHEREAS, one hundred percent of the 6,322 acres the US Army leases from the State of Hawai‘i at MMR, KTA, and Poamoho are Hawaiian Kingdom Crown and Government lands which were seized by the US Government and transferred to the State of Hawai‘i without the

consent of or compensation to the Native Hawaiian people of Hawaii or their sovereign government;³

WHEREAS, on June 7, 2024, the US Army released a Draft Environmental Impact Statement (EIS) and opened a public comment period which ended on August 7, 2024 to analyze the potential environmental impacts associated with retaining these lands O‘ahu and continue military use of the State lands at these three installations on O‘ahu.

WHEREAS, in the Draft EIS, the US Army admits that there will be “significant adverse impacts” on land use (land tenure) and environmental justice with the retention of any lands at Kahuku, Poamoho, and Mākua.⁴

WHEREAS, MMR, Poamoho, and KTA are home to dozens of endangered native organisms and fragile ecosystem and the US military has not always been good caretakers of Hawai‘i’s natural resources, lands, and water (e.g. Red Hill fuel spill);

WHEREAS, Furthermore, for decades the US Army has been responsible for the desecration of ancient Hawaiian sites and burials and limiting Native Hawaiian cultural access in Mākua, Poamoho, and Kahuku.

WHEREAS, the US Army training areas pose a threat to nearby adjacent communities with toxic emissions, noise pollution, and fire risks while perpetuating an ongoing legacy of unexploded ordinance, invasive species, and the contamination of water sources and soil.

THEREFORE LET IT BE RESOLVED, that the United Methodist Church ally with and advocate on behalf of Native Hawaiians on interconnected justice issues on an ongoing basis. This includes but is not limited to the issues of land theft and reclamation, environmental justice, and protection of cultural resources.

THEREFORE LET IT BE RESOLVED that the Hawai‘i District and the California-Pacific Annual Conference of the United Methodist Church strongly urges the Department of Land and Natural Resources (DLNR) take no action on the US Army leases of 6,322 acres at MMR, KTA, and Poamoho, and that they be allowed to expire.

THEREFORE LET IT BE RESOLVED, that the Hawai‘i District and the California-Pacific Annual Conference of the United Methodist Church strongly urges that the US military clean up, restore, and return the lands they occupy to the rightful owners, the Native Hawaiian people.

THEREFORE LET IT BE FINALLY RESOLVED, that copies of this resolution shall be sent to the Director of the Department of Land and Natural Resources; Hawai‘i State Governor, the Hawai‘i State House Speaker; the Hawai‘i State President of the Senate; the U.S. Army Garrison Command, Hawai‘i; Hawai‘i Members of the U.S. Congress; the Office of Hawaiian Affairs.

Grace and peace to you in the sovereign name of Jesus Christ. It continues to be a great blessing and honor to serve as the Hawaii District Superintendent. We have had many landmark events to celebrate and I am personally grateful to the pastors and laypeople of our Hawaii District churches for their faithfulness and graciousness.

One of the proudest moments for our Hawaii District was when the 2024 General Conference passed legislation to apologize formally for the illegal overthrow of the Kingdom of Hawaii in 1893, with participation from Methodists, leading to the subsequent occupation and annexation of Hawaii by the United States. The AOR Taskforce continues to do work on awareness about and justice for Native Hawaiians.

One of the most inspiring events during this past year was the first all-district young adult retreat to be held since before the COVID pandemic. Over 50 participants from several churches and different ethnicities gathered at a camp on the North Shore of Oahu. The Rev. Ken Suhr, our conference director of leadership and congregational vitality, was the keynote speaker, and the Rev. Joe Yun was the camp director. The success of the camp has inspired much enthusiasm and more district events for youth and young adults are being planned.

**Church Location and Building Subcommittee
of the Hawaii United Methodist Union
Report for May 2024 to April 2025**

This year the Church Location and Building Subcommittee has worked with a number of items for its review and approval. Each will be discussed below.

This is a reminder to all churches in our district that there is a mandatory requirement that when a church plans to construct, purchase or remodel a church, educational building or parsonage and if the remodel cost will exceed 25% of the value of that building, such church must submit their project plan/proposal to the Church Location and Building Subcommittee for its review, discussion, recommendations and approval.*

The first work of the Committee this year was a combined review of the repairs of the Wesley Foundation facilities and the associated Center Street parsonage. The parsonage is having substantial problems due to foundation issues and internal defects. The DS agreed to bring in an engineer to determine how to fix the foundation issues. A contractor has been selected to work on the interior issues. The Wesley Foundation issues are to be resolved under the direction of its pastor in charge. Both issues are to be paid for by the District since all those facilities are the property of the District.

The Subcommittee is also reviewing the status of Camp Mekokiko, the Pahala church property and the Britt's lot in Puna on a regular basis.

Another matter that came to the Subcommittee was the proposed sale of a portion of the Trinity UMC property to the City and County of Honolulu. The church plans to use the sales proceeds to complete repairs to its sanctuary roof and, potentially, purchase a new parsonage. The Subcommittee recommended proceeding with the sale.

We are currently reviewing some major repairs and improvements to the Hilo UMC. Some of its driveways need to be replaced and a convenience walkway is to be constructed around the front of the church sanctuary building. This process is underway at the moment.

I appreciate and give thanks to all the members of the Subcommittee for their commitment, to Sonya Lee for her support and to District Superintendent Rev. Dr. Tom Choi for his leadership. On behalf of the board, I appreciate the pastors and laity for their willingness to comply with the Book of Discipline and their cooperation in following the process in maintaining and utilizing sanctuaries, facilities and parsonages to continue our witness of Jesus Christ and the Good News in the world. And BOD Paragraph 2544 provides the steps or rules for the planning process. Please review paragraphs 2521, 2541, 2544 and other paragraphs that relate to the church properties from BOD. The most common, forgotten thing is when a local church plans to rent/lease its parsonage and/or facilities. If it is for 30 days or more, a local church must have approval from this board with the written consents from the pastor of the local church and district superintendent according to Paragraph 2541. This required process has been forgotten or bypassed by some of the local churches.

Hawaii Committee on Ordained Ministry
District Conference -- May 10, 2025

The Hawaii Committee on Ordained Ministry (HCOM) meets several times a year to interview local pastors to give them support and to renew their license to preach, to interview all those who are in the candidacy process as certified candidates, and to interview all those who are called to the ministry and are ready to enter the candidacy process. Every other year we interview any Certified Lay Ministers for re-certification. In August we meet with any local pastor or candidate who is eligible to apply to the Cal Pac Conference Board of Ordained Ministry for Commissioning, to approve them to apply. That is the first step at the conference level for ordination.

We want to thank each HCOM member for their time and expertise reading papers submitted by the candidates, and the care of local pastors and candidates at the interviews and through the year.

Hawaii District Lay Servant Director's Report

This year marks my first as Hawaii District Lay Servant Director, and it has been a period of learning and growth. I am especially grateful to Winnie Ching for her mentorship and for generously sharing her insights.

Each month, I participate in Zoom meetings with the Cal-Pac Conference Lay Servant Directors. These meetings focus on planning upcoming classes and identifying the needs across our districts. Several directors are also new to their roles, which has fostered a collaborative environment where we support and learn from one another.

A unique challenge for Hawaii is our geographic distance from California, which can make the timing and accessibility of classes offered on the mainland difficult for our members. Additionally, the separation between islands adds another layer of complexity to our efforts.

Jennifer Gaylord maintains an updated spreadsheet of all Lay Servants and Certified Lay Ministers in the conference. I have been reviewing the status of Lay Servants in the Hawaii District and reaching out to those who are inactive; defined as not having submitted an annual report in the past 18 months. I contacted these people and I learned that one individual is no longer interested in serving, while about five others were unaware of the reporting requirement to maintain active status.

As of April 12, 2025, the Hawaii District has:

- 2 Certified Lay Speakers
- 23 Certified Lay Servants
- 1 Certified Lay Minister

On January 30 -31 I attended a conference on Lay Servant Ministry in Nashville, Tennessee with the other district directors. It was good to connect with the directors that I had only met through Zoom. The conference had many good speakers and talked about new classes to be offered in the future. As is often the case, some of the most meaningful learning took place during informal conversations with fellow attendees.

Looking ahead, my goals for the coming year are to increase awareness of Lay Servant Ministry and the opportunities it offers, and to encourage greater participation in classes. I am also committed to inspiring more individuals to pursue certification as Lay Ministers.

Transforming Christian Leaders

District Planning and Strategy Committee

Our team hosted another Clergy Retreat on August 19-21, 2024 at St. Anthony's Retreat Center in Kalihi. 17 local clergy from 3 islands attended the retreat for rest and renewal with the theme: A New Thing! Clergy had time to share their ministry ideas, play games, get massages, hear from speakers, and be inspired by our DS Tom Choi. It was a great success. The District Leadership Team will be taking the lead for the next clergy retreat.

2025 District Conference Report

Hawai'i Acts of Repentance Task Force

After our Apology Resolution was passed at the 2020/2024 General Conference, we focused our energies on working with Native Hawaiians to restore crown lands. In 1964, the U.S. Army signed 65-year leases for \$1 per lease with the State of Hawai'i, Department of Land and Natural Resources, for 782 acres at Makua Military Reservation (MMR), 1,150 acres of land at Kahuku Training Area (KTA), and 4,390 acres at Kawaihoa-Poamoho Training Area (Poamoho). The leases are set to expire in 2029 and the Army has requested renewal of all three leases. AOR sent testimony against the renewal of leases for the Environmental Impact Studies at KTA and Poamoho and testified in person at the MMR hearing in Wai'anae. We later sent testimony supporting bills against the renewal of these leases to the 2025 Hawai'i State Legislature. Finally, we drafted a resolution to our 2025 Cal-Pac Annual Conference addressing these leases and calling on the State of Hawaii. (see attached)

In September 2024, we wanted to inform the District about our work and so held a hybrid in-person and online presentation that included new information about Hawaiian history, the General Conference experience, and plans for the future. Several people from Hawai'i UMCs attended.

Several AOR members participated in activism on January 17, 2025, the anniversary of the overthrow of the Hawaiian kingdom. Some participated in the Onipa'a March, others staffed information and water booths at Iolani Palace, and others attended a simplified version of the Ho'okuikahi Worship Service led by Kahu Kaleo Patterson.

We also connected with Hawaiian artist Meleanna Meyer and collaborated with her to host the 'Aina Aloha mural at United Methodist Churches. The mural went first to Wesley UMC from January to April 2025. A workshop for members of the church and members of AOR was held on March 15, 2025. The mural is now moving to Harris UMC for display and a workshop with Meleanna will be held there as well (details to come). If any other UMC would like to host the mural, please contact Amy Wake.

In February, we did a presentation for the Mission of Peace youth group from the North Eastern Jurisdictional Conference with Bishop Cynthia Moore-Koikoi. We also hosted the Britt Lecturer Rev. Dr. Grace Kim for a tour of Iolani Palace and an informational meeting.

We have been working to connect with the UMC General Commission on Religion and Race to organize the apology to Native Hawaiians here in the islands and also at the next General Conference in 2028. There is a sub-committee from GCORR who will lead the work. The GCORR board will be coming to Hawai'i in February 2027.

The AOR Task Force meets regularly to further UMC connections with Hawaiian leaders and activists and work towards a meaningful apology. If you would like to learn more about AOR, please contact Amy Wake.
