SOUTH DISTRICT COMMITTEE REPORTS

Lay Leader Report

Michael Mitchell

It has been a blessing to serve as the South District Lay Leader this past year. Our district is filled with dedicated laity and clergy who continue to work faithfully in ministry and mission. My focus this year has been on strengthening connections among churches, supporting lay leadership, and encouraging spiritual growth.

One of the year's highlights was the in-person Certified Lay Minister and Lay Servant Ministries training on April 27, 2025, at Hope UMC in San Diego. Partnering with Cathy Wilson, Melissa Bosch, and DS Rev. Luis Garcia, we welcomed new and returning lay leaders for a full day of training, fellowship, and worship. The energy and engagement from participants affirmed the importance of continuing this work.

Another key part of my ministry was offering devotions during the 2024 South District Charge Conferences. I focused on lifting up the essential role of the laity in the life of the church, encouraging them to use their spiritual gifts in leadership and service. These messages reminded congregations that a Spirit-led laity is vital to the church's mission.

Throughout the year, I also helped lead a monthly South District Prayer Session, held virtually on the first Tuesday of each month at 7:00 p.m. These gatherings created space for shared prayer, reflection, and encouragement among laity and clergy across the district.

In addition, I supported churches through visits, attended district meetings, and offered care and guidance to lay leaders navigating transitions. I've continued to advocate for improved communication and for raising up young, bilingual, and culturally diverse leadership to reflect the richness of our district.

Looking ahead, I remain committed to equipping and encouraging the laity across the South District. I'm grateful to serve in this role and am always available to support our churches in whatever way I can.

Assistant District Director

It is a great honor to serve as the new Assistant District Director for the South District. Over the past seven years, my predecessor, Rev. Paige Eaves has been doing excellent work, helping local churches in many different ways, particularly with property development. With a sense of trepidation and humility, I recognize that I have big shoes to fill and a steep learning curve ahead of me. It will take me some time to get to know the churches and people of the South District.

Apart from my new role, I'm currently the Senior Pastor of Garden Grove UMC, a multicultural inclusive congregation with four language ministries (English, Korean, Samoan, and Vietnamese) in Orange County. I have been in ministry for over twenty-five years, twenty of which in the local church. Garden Grove UMC is my fifth appointment.

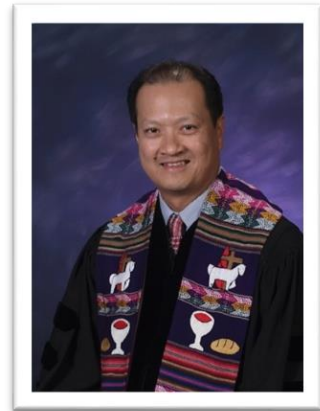
Prior to that, I worked as a government lawyer in the Swiss Federal Justice Department and later as a missionary with Wycliffe Bible Translators, managing translation projects in Africa. It was in northern Ghana in the summer of 2000—*sitting in a Jeep that broke down on a dusty road in the middle of nowhere*—when I received the call from God to enter the ordained ministry, which is proof that the Lord must have a great sense of humor.

Beyond the local church, I'm also a member of the Judicial Council of The United Methodist Church, first elected in 2016 for a term of 8 years and re-elected in 2024 for 4 years. The Judicial Council is the supreme court of our denomination, deciding cases on questions of Church law arising from around the global connection.

Born in Vietnam and raised in the German-speaking part of Switzerland, I attended the University of Bern, Harvard Law School, and Claremont School of Theology, and hold a Ph.D. in constitutional law from McGill University. I'm married to Traci, a pharmacist. We have two teenage sons, Benjamin and Timothy, a border collie (Oreo) and a cat (Kitty). Hadn't God called me into the ministry, I might have pursued my dream of becoming a guitarist playing in a rock band.

Thank you for your prayers, patience, and support, which I certainly will need. I am looking forward to working with you in the coming months.

South District Union

Jason Tucker

The South District Union has had a year of transitions since our last district conference! We welcomed Rev. Luis Garcia as our new Superintendent and said farewell to Rev. Paige Eaves as she moved into her new role as Assistant to the Bishop. We're also very grateful for Jan Newton filling in during Emilie's parental leave! We're also very excited to welcome Rev. Lui Tran as our Assistant District Director. His graces and talents will be a huge asset to our District in new ways this year.

As you may know the District Union stewards approximately \$4 Million in invested assets, whose earnings are used for the benefit of our ministries here in the South District. Our primary vehicles to serve our churches include 1) Strategic grants for new/improved ministries, in conjunction with District Planning & Strategy Committee and CalPac New Ministries, 2) Educational grants for pastoral candidates, and 3) Emergency grants and loans for congregations. We also have funding available to bridge clergy housing and health care needs for congregations receiving new pastors in the middle of their budget years.

In addition to our funding initiatives, the District Union has become much more involved in property transitions throughout our region, often serving as an intermediate custodian of church properties after congregations are discontinued. Managing this transition process helps to keep the assets and funds in service to the other churches in the district.

This year, we've continued learning in our role as "intermediate property custodians," and have been most heavily connected with property work at Surf City UMC, Winchester UMC, the Imperial Beach Neighborhood Center project, and Holtville UMC. Our goal in all these matters is to make sure that these assets are put to the highest and best use for our local ministries here in the district.

I am deeply grateful for our members, both lay and clergy from churches throughout the district, as well as our fantastic District staff. We are especially in debt to our board secretary, George Harris, our board treasurer, Marion Folkner, and our board investment advisor John Folsom. These three lay leaders are truly the backbone of the District Union!

District Missions

Pastor Jeri Newell-Davis

In this past year, the South District Missions Committee worked in a variety of ways alongside District churches as well as Conference committees. We came together as the body of Christ to assist in ways that offered support to local, regional, and binational communities. Here is some of what we accomplished along with our partners, Volunteers In Mission, United Women of Faith, Border Ministries, and Cal-Pac Disaster Task Force.

Border Ministries Donations:

Local churches and individuals have been instrumental in collecting and transporting items to sustain those in Tijuana who were waiting for immigration and asylum appointments. These items included infant, children, and adult clothing, diapers, assorted toys, toiletries, and hygiene kits, as well as food, water, and warm blankets. Although the work is not as robust as it was last year, it is still essential for those who wait on the margins. Your help is still needed to collect and transport items into Tijuana and Calexico. Please contact the District office if you would like to help.

Community Support:

May 2024, District churches went out with an emphasis of supporting their community's needs. These offerings included food collections for local food pantries, trash pick-up, collecting and making hygiene kits for those in need and baking cookies for First Responders. We continue to encourage local churches to choose a time and activity that impacts their local neighbors.

July 20, 2024, six South District churches walked in the San Diego Pride Parade as the UMC South District supporting our LGBTQ+ community. We hope you'll join us this year on Saturday, July 19th in San Diego and on Saturday, September 27th at the OC Fair Grounds.

May 1, 2025, the District offered its first Interfaith National Day of Prayer Service. This service of worship brought Christian, Buddhist, Muslim, and Jewish leaders together to pray for hope in our nation. We are grateful for San Carlos hosting and livestreaming this event.

Cal-Pac Support:

Many local churches offered gift cards, financial and physical support for neighbors in Altadena and Palisades after the devastating wildfires. This work continues and we are still assisting.

As we look forward to the coming year, we will continue to work collaboratively as we plan our District Harvest Walk. If you are interested in joining us, please contact the District Office.

District Committee on Ordained Ministry

This has been a season of transition for the South District Committee on Ordained Ministry. In the last year, we said farewell to the Reverends Christian Dement and Melissa Rusler, who served as chair and registrar, respectively. They provided outstanding and faithful leadership over a period of many years for which we are grateful. Rev. George Hooper graciously agreed to take on the responsibility of registrar for DCOM and I stepped in as chair. We were joined by a new District Superintendent, Rev. Luis Garcia, and together we have leaned into this new season and the meaningful work of DCOM. This committee is served by busy people who give of their time, energy and wisdom because they care deeply about the church as well as those who are exploring their sense of calling to ministry within the UMC. The committee is currently made up of 15 members, including clergy and lay people...elders, deacons, licensed local pastors and certified lay ministers. I am deeply grateful for their commitment to this important work, and I am honored to serve alongside them.

The South DCOM meets approximately six times per year, depending on the number of individuals in our care and where those individuals are in their process. We offer introductory meetings for exploring candidates at the beginning of their ministry journeys. We meet with candidates seeking initial certification as well as the annual renewal of their certification as candidates for ministry. Likewise, we meet with those seeking approval or annual renewal as Licensed Local Pastors. We meet bi-annually with Certified Lay Ministers for licensing and relicensing. And in the fall, we meet with those seeking to be recommended to the Board of Ordained Ministry for provisional membership.

Currently the South DCOM has within its care:

9 Exploring Candidates

10 Certified Candidates

15 Licensed Local Pastors Under Appointment

13 Certified Lay Ministers + 1 Candidate for CLM

Two additional candidates from South District, Maria Longley and Mark Maddix, will be commissioned at Annual Conference in June. We give thanks for God's grace and their hard work that has brought them to this place. We celebrate with and for them as they come for commissioning.

While the work of DCOM is not always easy, we seek the guidance of the Spirit and welcomes your prayers as we do our best to listen, to guide and to support each individual who comes into our care.

District Planning & Strategy Committee

I consider it an honor to serve as chair of the District Planning and Strategy (DPAS) Committee because true leadership begins with service. Just as Jesus came not to be served but to serve, I feel called to guide this team with a servant's heart—listening deeply, discerning faithfully, and working alongside others to help our churches flourish. Instead of having a spirit of competitiveness between the churches, I embrace our deep roots of connectionalism. It is a sacred joy to support ministries as they experience regeneration and resurrection.

I serve with a dedicated group of laity (5) and clergy (6) who nurture and resource our churches and ministries. Through microgrants, Georgia Lynch grants, and Equitable Compensation support, DPAS helps churches grow, thrive, and reach their communities in meaningful ways.

With hearts for revitalization, DPAS also sends out teams to walk alongside congregations using the appreciative inquiry process—helping them rediscover their strengths and imagine fresh paths forward. This year, we have deepened our partnership with New Ministries at the Conference by joining them in their revisioning process.

Since our last District Conference, we have approved the following grants:

Microgrants:

- Chollas View – Spanish and Haitian Ministry: Translation equipment – \$5,000
- Good Shepherd Westminster – Xcavation Youth Ministry – \$5,000
- Julian – Community Café – \$2,700
- Normal Heights – Diversity and Inclusion Consultant – \$5,000

Georgia Lynch Grants:

We were also able to award 20 Georgia Lynch Grants totaling \$111,416 to support ministries for women, children, and youth in the district.

Equitable Comp Grants:

We recommended 5 Equitable Comp proposals to the Equitable Comp Committee.

A heartfelt thank you to each DPAS member for your time, care, and vision in helping to shape a more vibrant and connected church across our district. What a gift it is to serve together.

District Buildings and Locations Committee

Alan Hay

The Building and Locations Committee reformed at the beginning of 2025 with Alan Hay appointed Chair.

Our first meeting took place in February, and we discussed various ongoing and new property opportunities. Time has been spent putting together a draft plan for when congregations sell property and how they can invest the proceeds and use the investments for Missions and Ministry. More work will take place on this in 2025 as well as creating packages of information which detail the process to follow.

Rev Lui Tran was recently appointed Assistant District Director and he is currently transitioning into the support role for congregational development.

- **Integrating Faith and the Arts:** Through various programs, including a retrospective film screening series, the ministry encourages the campus community to explore the intersection of their faith and creative expression, fostering a holistic approach to spiritual development.
- **Fostering Interfaith Dialogue:** By participating in the Student Interfaith Council and co-sponsoring quarterly interreligious dialogues with the Office of Student Affairs and the Center for Spirituality and Ethics, the Wesley Foundation actively promotes understanding and cooperation among diverse faith traditions on campus .

Looking ahead, we remain committed to supporting the spiritual growth of UCSD students, nurturing a community where faith, intellect, and service intersect. We are grateful for the ongoing support of the United Methodist Church and the broader district community in this vital ministry.
